 - Purchase date
 - The Authorized Appliance Dealer where you purchased your unit. Please note, the Dealer name you select must match the dealer on your sales receipt.
 - Model number
 - Serial number**
 - Mailing & contact information
 Once you have entered all the necessary information, click 'Apply for Rebate'.
- Print the confirmation page and mail it with a copy of your sales receipt to the address shown. You will also receive an email confirmation. We must receive the confirmation and sales receipt in order to finalize your rebate claim and they must be postmarked no later than January 31, 2016. No email please.
- Upon review & acceptance of your submission, we'll mail you a check. Please allow 6-8 weeks for payment from the time we receive your confirmation and sales receipt.

*Purchases made from an Authorized HVAC Distributor, Parts Dealer, Service & Repair or Manufacturer's Rep Firm do not qualify for a rebate.

** The serial number will be four letters followed by five numbers and can be found on the UPC Label on box/carton your unit came in. You can also find it behind the front cover of the unit on a barcode label.
