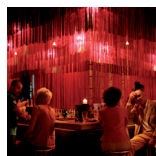
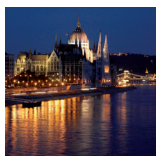

Promotion Terms and Conditions

1. This Promotion is open to all UK residents aged 18 or over who hold a valid machine readable passport and who comply with these terms and conditions. 2. This Promotion will run from 12th September 2007 and will continue until the earlier of either 11:59pm on Tuesday 13th November 2007 or the date and time at which a total of 8,000 successful applications have been made to claim for Landround Travel Limited ("Landround") flight vouchers (the "Vouchers"). 3. To receive a Voucher, Amazon.co.uk customers (the "Customer") must (between the dates mentioned above in clause 2) purchase any two travel guides from the 60 titles featured in the promotion at www.amazon.co.uk in one transaction from www.amazon.co.uk. Purchases made from third-party sellers at Amazon.co.uk's Auctions, zShops or Marketplace or at any of Amazon.co.uk's Trusted Partner sites, or from Amazon.com, Amazon.de, Amazon.fr, Amazon.co.jp, Amazon.ca or Amazon Jersey are not valid. Customers need to then print and fully complete the claim form available at www.amazon.co.uk. They should then send the completed claim form along with their official AMAZON purchase confirmation receipt (the "Receipt") and a stamped self addressed envelope to "Rough Guides/DK Eyewitness Flight offer, Discover Promotions, PO Box 1095, Chester, CH1 4WH". All claim forms must be received by **29th February 2008**. Landround will send the Customer their Voucher within 14 days of receipt of correctly completed claim form. 4. Landround will only accept claims correctly completed in accordance with paragraph 3. In the event the claim is incomplete, inaccurate or false Landround will send the Customer a letter informing the Customer that they do not qualify for the Voucher using the stamped self addressed envelope. 5. The Voucher entitles the recipient to a return flight to one of the following destinations: Amsterdam, Barcelona, Brussels, Dublin, Edinburgh, Geneva, Malaga, Milan (Bergamo, Linate or Malpensa) or Paris from the following London airports; Luton, London Gatwick, London Heathrow and Stanstead. 6. Landround reserves the right to select the London departure airport from Gatwick, Heathrow, Luton or Stanstead. Departures from other UK airports may be available and may require a supplement payable by the Customer. This supplement will vary according to the airport and availability. 7. Airport taxes and passenger service charges are not covered by the Voucher and where known, must be paid by the Customer upon confirmation of any booking. Airport taxes vary depending on: destination/departure airport and time of travel. 8. All reservations are subject to Landround /airline availability. This may be limited at certain peak periods and/or during periods of major international events e.g. sports championships. All travel must be completed by 30th June 2009. First, second and third choice dates will be requested at the time the Customer receives their Voucher, but neither Landround nor the Promoter guarantee availability of these dates. 9. Only one Voucher may be used per household/booking. This means, if there are two people in the household and they both complete the terms of entry, they are each entitled to a Voucher, but are only able to redeem one Voucher per booking and are unable to travel on the same flight using both of their Vouchers. If they do wish to travel on the same flight, and are travelling from a London airport (as specified in clause 5) there is a set price of £75 for 1 additional passenger (excluding airport taxes and passenger service charges). As stated in clause 6, this price may vary if travelling from a different UK airport. The second passenger is guaranteed to be on the same flight if both flights are booked together. You will be asked to confirm this information when you receive your Voucher. 10. Travel insurance is essential for all air passengers, but is not included with the Voucher. Evidence of adequate travel insurance must be presented by the Customer at the time of confirming all flight bookings. 11. Photocopies of Vouchers are not accepted. 12. No cancellations or amendments are possible after confirmation of your booking. Airport taxes, passenger service charges and any charges for additional services are also non-refundable once your booking is confirmed. 13. Landround and the Promoter reserve the right to select the airline carrier and cannot be held responsible for any alterations to flight schedules, routes and destinations. 14. Bookings must be made a minimum of 30 days before travel. Passengers must stay at least one night in their chosen destination. 15. Passports, Visas and other documentation are the responsibility of the passenger. Landround Travel Limited and the Promoter accept no responsibility for travel that cannot be completed due to failure by the passenger to secure such documentation. 16. The booking instructions, "How to book" and all other information stated within the Voucher also form part of the terms and conditions of this offer. To book your flight through Landround you need to complete your booking request form indicating a) your first and second chosen dates of travel; b) your first and second choice of destination, clearly marked; c) any additional passengers you would like to accompany you; d) any additional services (accommodation, car hire, insurance etc) by ticking the correct boxes. Send the completed booking form to the address shown. Landround will contact you within 14 days of receipt of your booking request. 17. Travel to and from any airports is excluded from this promotion. 18. The booking instructions on the Voucher, 'How to Book', and all other information stated within this document also form part of the terms and conditions of this offer. 19. The Voucher is not transferable and cannot be resold. 20. No responsibility can be accepted for lost, damaged, illegible, incomplete or mislaid Vouchers. Proof of posting is not proof of receipt. 21.
